IN ADDITION OUR EDUCATIONAL PROGRAMS ALSO INCLUDE EXHIBITIONS, ARTIST IN RESIDENCY AND MUSICAL PERFORMANCES. EXHIBITIONS ARE AN ESSENTIAL PART OF THE TIMKEN'S EDUCATIONAL PROGRAMS AND WE BELIEVE OUR FREE ADMISSION MANDATE PROMOTES ART AWARENESS AND APPRECIATION BY MAKING OUR COLLECTION ACCESSIBLE TO ANY AND ALL THAT VISIT.

THE FOUNDATION WOULD LIKE TO EXPLAIN THAT THE OPERATING INCOME TOTALING \$7,273,215 ON THE FORM-990 INCLUDES A PLEDGE TOTALING \$7,488,000 NET OF THE PLEDGE DISCOUNT OF \$512,000 THAT IS FOR CAPITAL IMPROVEMENTS. THE FOUNDATION HAS A NET OPERATING LOSS NET OF THIS PLEDGE OF (\$214,785). THIS LOSS IS DUE TO CERTAIN ADJUSTMENTS TO THE INTERNAL FINANCIAL STATEMENTS THAT ARE REQUIRED TO BE REPORTED DIFFERENTLY IN THE FORM 990. THE MOST SIGNIFICANT ADJUSTMENT IS DUE TO THE TREATMENT OF THE TWO ENDOWMENT FUNDS. THE PUTNAM FOUNDATION HAS A BENEFICIAL INTEREST IN THE PUTNAM FOUNDATION TRUST (PERPETUAL TRUST) AND THEREFORE IS ABLE TO RECORD THE DISTRIBUTIONS TOTALING \$694,530 AS INCOME. HOWEVER, THE TIMKEN AMES ENDOWMENT IS 100% OWNED BY THE FOUNDATION AND AS SUCH IS NOT ABLE TO RECORD THE DISTRIBUTIONS \$408,465 AS INCOME.
